

**NOTICE OF PUBLIC HEARING ON THE PROPOSED CHANGES TO THE RATES AND CHARGES FOR
THE USE OF AND THE SERVICE PROVIDED BY THE MUNCIE SANITARY DISTRICT**

Notice is hereby given that, on February 5, 2025, the Board of Sanitary Commissioners of the Muncie Sanitary District introduced Resolution No. 2025-02 Amending the Schedule of Sewage Rates and Charges for the use of and the service provided by the Muncie Sanitary District.

Notice is further given that a public hearing will be held before the Board of Sanitary Commissioners of the Muncie Sanitary District on Wednesday, February 19, 2025, at the hour of 11:30 A.M. at the Muncie City Hall Auditorium located at 300 N. High St., Muncie, IN 47305, at which all users of the sewage works and owners of property served or to be served by the works, including interested parties, have had an opportunity to be heard concerning Resolution No. 2025-02 Amending the Schedule of Sewage Rates and Charges for the use of and the service provided by the Muncie Sanitary District.
